### **Positive Action in Recruitment**

The ideal candidate will be responsible for providing a safe, fun and engaging environment for children aged 3 to 11 years old after school between 2.45pm and 6pm Monday to Friday during school term time. Activities are play based and support children's learning, confidence and social skills.

The main things you will be asked to do in this role:

### Key Responsibilities:

- Supervise and ensure the safety of all children in the after-school club on and off site
- · Collect children from school and liaise with school staff
- Plan and implement a range of activities, including arts and crafts, sports, games, and educational projects.
- Foster a positive and inclusive environment where all children feel valued and respected.
- Safeguard children and report all concerns in line with the After school club policies
- Communicate effectively with parents and guardians about their child's progress, messages from school and any concerns.
- Maintain accurate records of attendance and any incidents/accidents.
- Ensure the club environment is clean, organised, and well-maintained.
- Adhere to all health and safety regulations, childcare and organisation policies including risk assessing activities and equipment
- Prepare snacks and supervise meal times

- Able to demonstrate an excellent work ethic.
- Able to demonstrate correct use of English when supporting children's learning
- Able to support children on guided walks between local settings
- Able to support children in indoor and outdoor games and activities
- Able to work in a team setting
- Able to use our IPAD software for recording child attendance and development
- Able to commit to learning and development opportunities around supporting children
- Knowledge of the requirements to safeguard children
